- lammaanahaaga aan guursan oo aad la wadaagto xiriir deggan



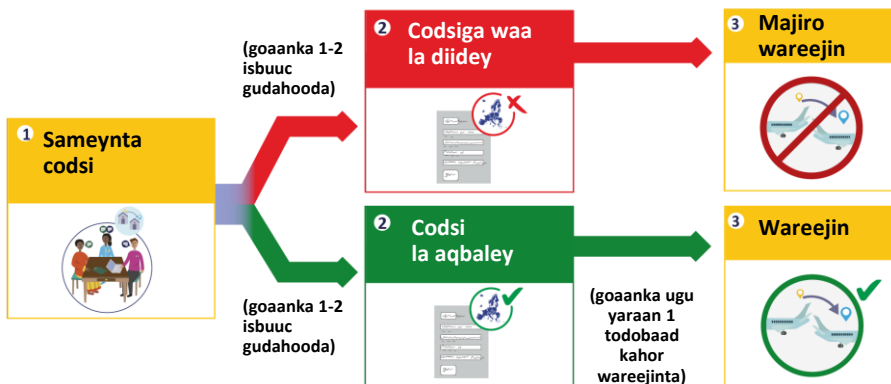
- ilmahaaga (ka yar da'da 18 sano oo aan guursan).

Haddii lagu raro waddan kale, xuquuqahaaga sida qofka helay magangelyo ayaa si toos ah ugu wareegi doonta waddankaas.



Buug-yarahan waxaa loogu talagalay ujeedooyin macluumaad oo keliya. Keligii ma abuuru xuquuq ama waajibaad Hay'adda Midowga Yurub ee Magangalyada (EUAA) ayaa bixisay qaybta ugu weyn ee agabkan, waxaana EUAA kaliya oggolaatay in ay nuqliyaan ama wax ka beddelan buug-yarahan Waddamada Xubnaha ka ah EU. EUAA ma qaado wax mas'uuliyad ama xil ku saabsan saxsanaanta, nuxurka, dhameystirnaanta, sharcinimada ama kalsoonida macluumaadka ku jira buug-yarahan ee ay bixiyeen Waddamada Xubnaha ka ah EU ama dhinac saddexaad oo mas'uul ah. EUAA iyo cid kasta oo ku shaqaysa magaca EUAA midna mas'uul kama aha isticmaalka laga yaabo in laga sameeyo macluumaadka ku jira buug-yarahan.
