- death penalty, torture or inhuman, degrading treatment;
- threats of violence caused by international or internal armed conflict.

Asylum seekers in Latvia live very secluded life. Language barrier, different culture, religious traditions, other skin colour, lack of knowledge about local traditions and social customs and society attitude hinder those persons to integrate in social life. Latvia has established asylum seekers reception system what still needs improvements.

Project «Step by step» continues formation of asylum seekers support system by elaborating asylum seekers integration system in social and professional life of Latvian society as well as contributes rising of public knowledge about asylum seekers. Project activities take place in Liepaja and Riga in time frame from April 2005 till December 2007.


